# President's Message...

Greetings Milwaukee Zontians;

Spring has sprung!!... so the Weather man says. Spring is a special time; a time of renewal. It's a time for new situations and new phases to begin in life...especially for our young girls and young women. Many of them will be moving on to middle school, high school, get their first summer job for college, etc. The season is also ripe for romantic, summer relationships, from "puppy love" to "going steady".

This is also an opportune time for us, as Zontians, to talk with young girls and women including, but not limited to our daughters, granddaughters, god-daughters, younger sisters, cousins and nieces about the subtlety of emotional, psychological and physical domestic abuse.

We know that what can appear as smothering, isolating attention can lead to controlling behavior; what seems like innocent critiquing can lead to belittling, hurtful words, that withholding approval or affection can challenge ones selfesteem and self-worth. This kind of behavior and the acceptance or tolerance of it can be the forerunners of abuse.

Let's counsel our young girls and young women to have confidence in themselves. Of course, we want them to consider the opinions of those important in their lives, but when any negativity becomes constant, non-ending and hurtful, they need to know it might be time to step back and assess the relationship or the situation.

Our biennial theme is "Conviction, Commitment and Courage"...and we believe in it as it relates to women the world over...the best place to promote it is with women around us!

# Meeting Minutes

March 18, 2015

The dinner meeting was called to order by President Donna Kahl-Wilkerson at 6:15 p m.

Missy Creevy distributed a prayer that was provided by Donna Conant, which we read together.

Barbara Wyatt Sibley introduced speaker, Janine Geske: Justice Geske graduated from Beloit College with a Bachelor of Arts degree and a Masters of Arts in Teaching and received her J.D. from Marquette University Law School. At Marquette University Law School the Restorative Justice Initiative (RJI) was created in 2004 under the leadership of Janine Geske, distinguished professor of law and former justice of the Wisconsin Supreme Court, to help support victims and communities in the process of healing from the effects of crime. With Professor Geske's retirement from the full-time faculty in 2014, the RJI has been combined with the Law School's other academic programs. Marquette University offers a 1 credit course working with the Green Bay Prison Restorative Justice Program, which includes the participation of students in a three-day restorative justice program for inmates. Janine Geske directs the Restorative Justice Clinic and teaches restorative justice; facilitating victim-offender dialogues in crimes of severe violence, and designing restorative justice processes.

Zonta members learned from the speaker the three key components addressed as part of Restorative Justice - What is the harm? Who was harmed? How can the harm be repaired? We learned that the "Victim" also has three parts - the victim or survivor of the harm, the community, and the offender. Restorative Justice often answers the questions of what happened in the last minutes of life - bringing some resolution and clarity to those harmed. The practice of Restorative Justice is intense and deeply personal - life changing for all participants.

Advocacy Committee: Diane Lindsley brought up the Safe Harbor Bill. A "Safe Harbor Bill" urges the Legislature to enact the Safe Harbor for sexually exploited children. Despite the fact that children under the age of 17 cannot consent to sex, children as young as 11 and 12 are routinely charged and incarcerated for prostitution. The goal is to stop treating exploited children like criminals and provide them with services and safe houses – not jail cells. Zontians were given the opportunity to contact their representatives to support this kind of legislation.

**International Women's Conference**, **Diane Lindsley**. There were seven Zonta Club of Milwaukee members at the event. The Zonta Club of Milwaukee panels which Joni Reese set up were informative and looked wonderful. We displayed our banner, and distributed information about the upcoming Fashion Show.

**Zonta Fashion Show, Joni Reese and Carol Cline**, Zonta preparations are going well, and moving forward in a timely manner. Lynne Oehlke requested help with raffles, set up and clean up. April 4, 2015 is the deadline for wine donations.

**Scholarship Programs, Missy Creevy**, reported that applications are in for the Young Women in Public /affairs, and a decision will be made next Wednesday, March 25, 2015. We have one applicant from Green Bay, as we are the closest club. Please help bring in applications for the scholarship, women in STEM and Women in Business. The information is on the Web. Please spread the word. the application due date is June 15, 2015.

**Treasurer Report, Diane Lindsley** reported that the finances are in order. This year membership dues and fees total \$170.00. Make checks payable to the Zonta Club of Milwaukee. To avoid late fees, dues will be required no later that April 22, 2015, which is the April meeting date. There will be an opportunity to charge yours dues, however, that will only be possible at the Zonta Fashion Show, April 18, 2015.

# Meeting Minutes Continued...



#### **JMK Women in Business**

\$1,000 + \$1,000 + \$7,000

Women studying business at the undergraduate or master's level at an accredited college or university, who show outstanding potential in their chosen field of business, are eligible to compete in this tri-level (club/district/international) Jane M. Klausman Women in Business Scholarship competition.

Zonta Club of Milwaukee applicants must either be a Southeast Wisconsin Resident enrolled in any local or out-of-state accredited college or university, or be an Out-of-State Student attending an accredited college or university in the six-county greater Milwaukee metro area.

In addition, applicants must have achieved or surpassed "junior" status by June 15, 2015 to be eligible

The Zonta Club of Milwaukee awards a \$1,000 scholarship and forwards the winner's application to Zonta District 6 for consideration in terms of an additional \$1,000 scholarship award.

The district winner's application is then sent to Zonta International for consideration in terms of one of the twelve \$7,000 international scholarship awards.

Complete applications are due on or before June 15, 2015.

#### Women in Science/Technology/Engineering/Math \$1,000

Women majoring in Science, Technology, Engineering or Math (STEM) who show outstanding potential in their chosen field are eligible to apply for this \$1,000 scholarship offered by the Zonta Club of Milwaukee.

Applicants must have an outstanding academic record and demonstrate intent to complete their chosen program.

Applicants must either be a Southeast Wisconsin Resident enrolled in any local or out-of-state accredited college or university, or be an Out-of-State Student attending an accredited college or university in the six-county greater Milwaukee metro area.

In addition, applicants must have achieved or surpassed "junior" status by June 15, 2015 to be eligible.

Complete applications are due on or before June 15, 2015.


