President's Message...

Greetings Milwaukee Zontians!

Mary Robinson, a Bonny Irish Lass!

Mary Robinson was born in Ireland in 1944. She was the 7th President and the first female President of Ireland. She also served as the United Nations Commissioner for Human Rights.

Mary became a member of the Irish Senate and served from 1969-1989, a mere 25 yrs old. She worked in academics (teacher), Barrister (Lawyer) and campaigner for politicians. Mary reached out to the Irish Diaspora and changed the face of Anglo-Irish relations. She was the first President of Ireland to visit Queen Elizabeth II at Buckingham Palace, the first President to meet with the Pope during her tenure and the first Irish President to meet with the Dalai Lama.

Mary has been awarded Amnesty International's "Ambassador of Conscience Award." She was chosen by the United Nations to oversee the implementation of a peace deal to stabilize the troubled Central African country of Congo. Kudos for the Irish charm and hard work of our Irish sisters, wherever they are!

Service Corner

NEU-LIFE PARTNERSHIP ARTREACH

Middle and high school boys in the ARTREACH program have completed two paintings and are working on finishing a third. One additional painting will be completed by a group of high school girls in the next several weeks. The works will be available for display by mid-April, along with a paragraph description of the message of the artwork.

Two venues have already been determined for display of the artwork. One is a April 30 training event where 2-300 youth workers from programs all over the City will gather to learn and share experiences. The second is the May 18 Neu-Life Annual Art Show and Luncheon. We will plan a display event for Zonta as well, and brainstorm opportunities for broader community communication.

ART SHOW/FUNDRAISER

This year's Art Show and Luncheon theme is "I Can Be Anything". Artworks are already in progress, and special items (beyond past years' journals, note cards, and prints) will be produced during Neu-Life's Spring Break Art Camp April 6-9. The ARTREACH paintings (not for sale) will be displayed in an area called "I Can Be An Advocate for Others" during the event. Of course, paintings and rain barrels will be available in the silent auction.

This year, the silent auction will also include Neu-Life "experiences" that highlight important aspects of their program: a meal catered by the youth cooks with food grown in the Neu-Life gardens, a private art class or birthday painting party taught by Neu-Life student artists, perhaps a visit/consultation by the gardening crew or a workout with the boys' basketball team. Staff are working with the youth to flesh out the offers.

Anyone with ideas for event publicity, please share them with Jody Rhodes, Tracy Hrajnoha or me. What we're planning now are email or social media blasts to Neu-Life friends and associations who support or are involved with them (and their member/distribution lists), announcements in church bulletins and schools, the neighborhood news service, posters in local businesses, and communication with MIAD students and faculty.

CAPITAL PROJECT

Construction is underway and should be complete by late August/September. If things go as planned, the upstairs bathroom reconstruction will be complete for the Annual Art Show -- yeah! Once the art room that Zonta is sponsoring is near completion, we'll engage all interested club members in working with the youth on a mural for that space. Expect this to be an early fall activity.

A few weeks ago, Neu-Life received a substantial grant that puts it at 97% toward the \$650K goal. Congratulations!

BEYOND NEU-LIFE: VOLUNTEERS NEEDED TO IDENTIFY OPPORTUNITIES FOR ZONTA ACTION



2015 Zonta Foundation Agency Recipients

Alverno College is an institution of higher education sponsored by the School Sisters of Saint Francis and dedicated to the undergraduate education of women. Zonta is supporting the Girls Advanced Academy in Science and Mathematics after school program. This program integrates chemistry, biology and mathematics by organizing hands-on experiential learning around two themes for girls "The Science of Food" and "The Science of Beauty". Students will learn how to think and work like a scientist to collect data, research and perform experiments.

Neu-Life Community Resource Center has been providing youth development programming for children in the Lindsay Heights Nerhgborhood in Milwaukee for the past 14 years. Neu-Life's mission is to empower youth with skills and strategies to make better life choices. Their programming is participant driven, meaning youth are directly involved in making decisions regarding the program and activities offered.

This year Zonta is pleased to continue funding for the ARTREACH portion of the "Anti-Violence Project". ARTREACH is an interactive creative arts program that has been developed by Human Trafficking Awareness Partnerships designed to instill a sense of awareness about human trafficking in our community's boys and girls. It will provide youth the skills needed to keep themselves safe as well as the opportunity to make an impact in the larger community through awareness building, peer advocacy and service.

Sojourner Family Peace Center-Established in 1978, Sojourner Family Peace Center is the largest non-profit provider of domestic violence services in Wisconsin. In the past year they have provided over 9,000 women, men and children with shelter, food, advocacy, education and support services aimed at helping them achieve freedom from domestic abuse.

As the largest provider of domestic services in Milwaukee, Sojourner is in a unique position to identify victims of domestic violence and human trafficking and to support their effort to achieve freedom from abuse. Because of this, Sojourner is working to increase their knowledge and capacity to effectively respond to the complex issues surrounding human tracking.

Zonta is pleased to continue funding this project which addresses the needs of domestic violence victims who have been trafficked. The goal of the project is to ensure that the victims of domestic violence and human trafficking have access to an array of effective, coordinated, and best practice, victim-centered services and supports aimed at help them achieve freedom and independence from their abuser/trafficker(s).

Our Next Generation helps inner city children develop essential academic, interpersonal and life skills leading to self-sufficient, responsible adulthood. The Phenomenal Ladies Program provides an essential service by giving young women to work with other teen girls and connect with positive adult mentors to help them become more motivated and learn to handle emotions, relationships and care for one's body. This year Zonta is proud to support the "BeU" project which is designed to address the challenge faced by young women in urban communities. The project focuses on empowering young women to be themselves and covers a wide range of topics including the perception of women in the workplace. Through this funding Our Next Generation will be able to continue the Phenomenal Ladies program for a group of adolescent tens who lack adequate home support and who have often suffered from physical, social and/or sexual abuse.

St. Catherine Residence provides safe, affordable and supportive housing to women with limited income who have diverse talents and needs and aspire to maximize their personal growth and employment opportunities. The Right Start program will utilize the funds provided by the Zonta Foundation to help women over age 18 who are pregnant or new mothers with very limited resources. This program will help subsidize housing for mothers and babies. Mothers will attend skill development sessions and participate in health planning for both mother and baby to ensure development of a healthy baby.

Waukesha Women's Center provides safety, shelter and support to women and their families affected by domestic violence, sexual assault and abuse and to facilitate their development. This 32 bed facility provides hope to over 300 individuals each year. Funding from Zonta will help in supporting the Emergency Shelter and Transitional Living program which is designed to promote healing and life skills development. This in turn empowers abused women to heal, learn the tools necessary to become financially empowered and to break the cycle of violence.

Zonta Club Dues for Fiscal Year June 2015-May 2016

The past year has been a successful one for the Zonta Club of Milwaukee. Our membership has grown from 39 to 45. Recent advocacy efforts focused on the *Zonta Says No* campaign and anti-human trafficking training at Neu-Life. Children at Neu-Life also received backpacks and Christmas gifts, and our member participation at Career Day, Art Fair, and Girls on the Run. Our 2014 fundraiser was a great financial and outreach success. Our dinner meetings have featured outstanding speakers as well as club brainstorming. JMK Women in Business

\$1,000 + \$1,000 + \$7,000

Women studying business at the undergraduate or master's level at an accredited college or university, who show outstanding potential in their chosen field of business, are eligible to compete in this tri-level (club/district/international) Jane M. Klausman Women in Business Scholarship competition.

Zonta Club of Milwaukee applicants must either be a Southeast Wisconsin Resident enrolled in any local or out-of-state accredited college or university, or be an Out-of-State Student attending an accredited college or university in the six-county greater Milwaukee metro area.

In addition, applicants must have achieved or surpassed "junior" status by June 15, 2015 to be eligible

The Zonta Club of Milwaukee awards a \$1,000 scholarship and forwards the winner's application to Zonta District 6 for consideration in terms of an additional \$1,000 scholarship award.

The district winner's application is then sent to Zonta International for consideration in terms of one of the twelve \$7,000 international scholarship awards.

Complete applications are due on or before June 15, 2015.

Women in Science/Technology/Engineering/Math \$1,000

Women majoring in Science, Technology, Engineering or Math (STEM) who show outstanding potential in their chosen field are eligible to apply for this \$1,000 scholarship offered by the Zonta Club of Milwaukee.




