Zonta Dinner Meeting

Wednesday, February 28, 2018

Speaker: Simmone Stovall, Healing Counselor, Aurora Healing and Advocacy Services

Our speaker for the February 28 meeting is Ms. Simmone Stovall, who is a healing counselor working for Aurora Healing and Advocacy Services located within Sojourner Family Peace Center as well as other programs and locations. She will discuss the Neurobiology of Trauma (deeply disturbing experiences) and how it affects our psychological and physiological being and responses. Trauma alters how we respond to stimuli and there's a need for more discussion about this topic in all service agencies.

Simmone will discuss how victims/survivors of trauma suffer with symptoms and how loved ones/supports can assist in the healing process. Labeling and stigma harms the people most affected by trauma. Do ALL people suffer from some trauma? She may discuss systemic trauma for people of color. It should be an interesting presentation.

Maria Bellmann, President Elect, called the meeting to order and read the invocation.

Speaker: Our guest and speaker was Felita Daniels Ashley of the Metropolitan Milwaukee Fair Housing Council. She spoke about the continuing need to make people aware of illegal housing discrimination and how to enforce laws regarding discrimination, fair lending problems and to assist communities to have inclusive housing policies.

New Member Installation: Patricia Taylor was installed as a new member.

Treasurer: As of 12/31/17 the checking account balance was \$12,898.64 and the CD balance was \$5083.37.

International Delegation Reimbursement: There was a recommendation to increase the reimbursement for our two delegates to the International Convention in Yokohama, Japan. This reimbursement has normally been \$2000 per delegate, but with the additional expense of travel, etc., it was suggested that this be increased to \$3500 per delegate, for 2018 only. Moved by Donna Conant, seconded by Jackie Beaudry and approved by voice vote. The 2020 convention will be in Chicago so don't expect a large reimbursement for that.

2018 International Convention Delegates: If anyone is interested in being a delegate to the convention, let Helen Ludwig know by 2/5/18. Email her at <u>hludwig@ludwiglaw.org</u>. The club will vote electronically for delegates.

Nominating Committee: Cheryl Lucas-DeBerry, Connie Thoma and Laurie Ward have agreed to be on this committee.

Advocacy: Montez Ashley is going to streamline and develop synergy with our advocacy efforts.

ARTREACH 2.0: Donna Neal reported that the paintings are on display in the Milwaukee City Hall rotunda until January 31. They will then be moved to the main library on February 5, where there will be a reception on Tuesday, February 6 from 6 to 7 pm. The agenda includes a welcome to Neu-Life Community Development and Zonta, and other anti-trafficking groups will be in attendance as well. Donna is also looking for people to drop into the library periodically to check on supplies for the display. There will also be a Neu-Life ARTREACH planning committee which will meet on January 30. Call Donna if you are interested in being on the committee, which will have one meeting per month for 3 months.

Madison Club Advocacy Activities: Diane Lindsley reported that the Madison club will hold their Afternoon of Action on March 8. This is an opportunity to meet with elected officials and staff to advocate for anti-slavery and anti-trafficking legislation. Additionally, the state legislature named January as Human Trafficking Awareness Month and it would be appropriate to contact Sen. Wanggaard and Rep. Vos to advocate for a hearing on Safe Harbor and on Truck Driver Trafficking Education bills.

Life, Liberty and the Pursuit of Happiness: Immigrants and Civil Liberties: This panel discussion will take place at Alverno College on February 20, 6-7:30 pm.

Fashion Show Fundraiser: There will be a meeting of the committee following the club meeting. Invitations were passed out to members at this meeting. Please bring any items you have for the raffles and auction to the February 28 meeting. We are also asking members to make a donation of \$20 for the wine purchase for the wine pull; don't forget to fill out a slip for the drawing for a \$25 Panera gift card in April.



Membership: Patricia Taylor was installed tonight.

Program: The next speaker will be Simmone Stovall who will speak about therapeutic treatment for victims of assault and trauma, which she has been providing since 2012.

Public Relations: The Fashion Show invites are online. Information regarding the Young Women in Public Affairs Scholarship is also on the club website.

Scholarships: The application deadline for the Young Women in Public Affairs Scholarship is March 15. Information for the scholarships due in June is not yet available.

Service: Joni Reese mentioned that there were a number of ideas for service projects in the agency applications to the foundation. She will review for a mini service project in February and potentially future months.

Z Club: Joann Comodore reported that new administration and changing liaisons between the club and the school have made it necessary to reorganize. The girls in the club are still enthusiastic and have had three major events this year: October – Silent Walk with the Zonta club; November – Boxes of food gathered and provided to Sojourner; December – Organized a Drum Line competition at the school. They are planning to work with the ARTREACH program in March or April.

Mentor: No report.

Foundation: Reported by Joni Reese – the board met earlier this month to review applications for grants. Seven grants will be awarded at the fashion show.



On January 30, the U.S. House of Representatives Subcommittee on Oversight and Investigations held a hearing titled "Following the Money: How Human Traffickers Exploit U.S. Financial Markets." The following witnesses testified:

- Mr. Bassem Banafa, Bassem Banafa, LLC., Financial Forensics Consultant
- Dr. Louise Shelley, Founder and Director of the Terrorism, Transnational Crime and Corruption Center at George Mason University
- The Honorable Cyrus R. Vance, Jr., District Attorney, The County of New York
- Ms. Tina Frundt, Founder and Director, Courtney's House

The hearing examined how financial institutions monitor, review, and verify depository relations with a payment processor. In particular, the Subcommittee sought to better understand potential problems and long-term challenges that exist, including examples of how human traffickers avoid detection.

UN Committee Report

"The Future We Want in Nepal"

The goal of our US\$1 million project with UN Women is to "create sustainable foundations for addressing the links between human trafficking and foreign labor migration of women and girls in Nepal."

Suggested Reading: "While the Gods Were Sleeping – A Journey Through Love and Rebellion in Nepal" by Elizabeth Enslin

Love and marriage brought American anthropologist Elizabeth Enslin to a world she never planned to make her own – living among Brahman in-laws in a remote village in the plains of Nepal. As she faced the challenges of married life, birth, and childbearing in a foreign culture, she discovered as much about human resilience, and the capacity for courage, as she did about herself. "While the Gods Were Sleeping" is a love story, an adventure narrative and an anthropological study.

Scholarships



Young Women in Public Affairs Award

Application deadline: March 15, 2018

The goal of the Young Women in Public Affairs (YWPA) Award Program is to encourage young women to participate in public affairs by recognizing a commitment to the volunteer sector, evidence of volunteer leadership achievements and a dedication to empowering women worldwide through service and advocacy. Young women ages 16 to 19 (as of April 1 in the application year) are eligible to apply. UPDATE: District Award is now \$1,500

The Zonta Club of Milwaukee awards a **\$1,000 local scholarship** to an applicant living in the greater Milwaukee area and forwards the winner's application to Zonta District 6 to be considered for the district award, which has been increased to \$1,500. The district winner's application is then sent to Zonta International; 10 international recipients are selected from the worldwide district/region recipients to receive additional awards of \$4,000 each.

Please note: Z Club members are eligible to apply! Classified members and employees of Zonta International and Zonta International Foundation, and their family members, are not eligible to apply.

Jane M. Klausman Women in Business Scholarship

Application deadline: June 15, 2018

The Jane M. Klausman Women in Business Scholarships are awarded to women undertaking business studies who have demonstrated outstanding potential in the field.

Any woman undertaking a business/business-related program at an accredited university/college/institute, including online students, in at least the second year of an undergraduate program through the final year of a Master's program at the time the application is submitted, is eligible to apply. UPDATE: District Award is now \$2,00 UPDATE: 6 International Awards of \$8,000

Zonta Club of Milwaukee applicants must either (1) have legal residency in the six-county greater Milwaukee metro area while attending any accredited university, college or institute in the world or (2) be a full-time, outof-state student attending an accredited university, college or institute in Milwaukee, Waukesha, Washington, Ozaukee, Racine, or Kenosha counties.

The Zonta Club of Milwaukee awards a \$1,000 scholarship and forwards the winner's application to Zonta District 6 for consideration for an additional \$2,000 scholarship. The district winner's application is sent to Zonta International for consideration for one of the six \$8,000 international scholarships.



Women in STEM Scholarship

Application deadline: June 15, 2018

As a means of encouraging more women to pursue undergraduate degrees in Science, Technology, Engineering or Math, the Zonta Club of Milwaukee is sponsoring a \$1,000 Women in STEM Scholarship.

Women of any age pursuing an undergraduate degree in Science, Technology, Engineering or Math, with either legal residency or out-of-state student status in the six-county greater Milwaukee metro area are eligible to apply. Applicants should have achieved junior- or senior-level status at an accredited college or university by the application deadline and demonstrate outstanding potential in the field.

- Supporting the MPS Annual Drumline competition hosted at MHSA in December (assisting with food sales, room monitoring, and assisting judges)


During this transitionary period, the focus and challenge of the Club and FEM Z Club is connectivity – STAYING CONNECTED.




Scenes from the ARTREACH Exhibit Opening Reception: February 6, Main Branch of the Milwaukee Public Library

(January 2018 Installation)


Proud mother of our 2017 Young Women in Public Affairs Scholarship winner, Erica Lofton.
