Unconscious Bias - Cheryl Lucas-DeBerry, MRA

Unconscious bias is embedded in our everyday decision-making and behavior in the workplace. Left unchecked, these mental shortcuts can create barriers to inclusion, engagement, and performance, which in turn impacts organizational effectiveness.

Objectives:

- Define unconscious bias, prejudices we have but are unaware of. They are "mental" shortcuts based on social norms and stereotypes that can cause us to make decisions in favor of one group over another.
- Examine unconscious bias through perceptions
- Explore our Trusted 10
- Identify ways to combat hidden bias

Update: Safe Harbor Legislation



The *Cap Times* of Madison recently published an update on the progress of Safe Harbor legislation in the state legislature. Below are excerpts from the article.

Victims of human trafficking, especially children, may feel trapped or even develop a bond with their abusers, advocates say. That's why they support "Safe Harbor" legislation, which would prohibit minors from being prosecuted for prostitution.

Supporters have previously tried to get the bill passed through the Wisconsin Legislature, but advocates are optimistic that increased understanding of the issue will make it a reality this time around....

The Wisconsin Coalition Against Sexual Assault has previously said the guilt and shame of being treated as a criminal may retraumatize children already suffering from guilt and shame at the hands of their abusers....

Advocates point out that other states have already enacted similar laws. Minnesota passed comprehensive human trafficking legislation, including a safe harbor provision, in 2011, and trafficking convictions increased dramatically.

The proposed legislation (known as LRB 0568) is authored by Rep. Jill Billings ,D-La Crosse, Rep. Jim Steineke, R-Kaukauna, Sen. Alberta Darling, R-River Hills, and Sen. LaTonya Johnson, D-Milwaukee. Advocates say the bill would ensure minors are not punished for the actions of abusers.

The 2018-2019 release is the fourth report on the status of girls in Wisconsin as part of Alverno's continued commitment to raise awareness regarding issues and challenges that impact girls in our state. The first report was released in 2007, with updates in 2010 and 2014. The report is still the most comprehensive consolidation of information about the issues facing girls in our state.

Marquette University Institute for Women's Leadership

Marquette University will be establishing an Institute for Women's Leadership with a \$5 million gift. The new institute will help Marquette develop research to influence the national discussion on gender inequality, and enhance leadership and career development programming serving women on campus and in the community, the university said in an announcement.

Wisconsin Women's Network

The Wisconsin Women's Network is an organization that promotes the advancement of women and girls in Wisconsin through communication, education, advocacy, and connections.

- Through their social media sites, they provide an easy way for women to get involved on an individual level, making sure that you're aware of what's happening in our community.
- Through their Policy Institute and Mentorship Program, they provide outlets for individuals to educate themselves, make valuable connections within the community, and learn how to advocate for their rights.

The **Wisconsin Women's Network Policy Institute** provides hands-on leadership, communications, and policy advocacy training to 25 women from around the state every year. Through a series of four two-day retreats in Madison, participants are organized into small teams which select a specific, real-world policy advocacy project that closely relates to the Institute's mission of improving women's health, safety, and economic security.

The goal of the **Wisconsin Women's Network Mentorship Program** is to give young women the opportunity to cultivate meaningful relationships with strong, inspirational role models throughout Wisconsin. The mentors are members of the Network's large network of women professionals. These mentors come from a variety of professions and backgrounds, all uniting under the same cause: they're dedicated to helping young women succeed. The Program matches these supportive mentors with undergraduate students to help young women navigate the transition from college to the workforce.

Racial Justice



The Racial Justice Committee was proud to host the January club meeting and program at Sojourner Family Peace Center. Carmen Pitre, Executive Director and former Zontian, welcomed us, provided updates on domestic violence in the Milwaukee area and on the center's activities and plans; she thanked Zontians for donating needed items.

For the program, Montez Ashley, co-chair of the Racial Justice Committee and human resources professional, led us in a Privilege Walk exercise and discussion. We had much meaningful dialogue and shared personal stories and experiences. Members described the experience as enlightening, thought-provoking, and moving. Many asked for follow-up action from the Club and the Committee. What can we do to create more awareness in Zonta and the community? What actions can we make to help create change in ourselves and our community?

On Thursday, February 7, the Committee met at Diane Lindsley's home for our regular monthly meeting. We debriefed the January club meeting, then talked about possible next steps. We created a preliminary plan to identify possible projects, programs, and activities to bring back to the club for consideration.

The plan includes:

- Making contact with local groups working to eliminate racism to collect information on issues and solicit ideas for where we might help
- Finding out what other Zonta Clubs are doing
- Researching specific topics like criminal justice reform, eviction, health and health care, and education
- Reviewing club meeting notes regarding possible mentoring activity
- Reviewing committee meeting notes on issues and resources

We plan to report back and share some ideas with the club in April.

Young Women in Public Affairs Award

The goal of the Zonta International Young Women in Public Affairs (YWPA) Award Program is to encourage young women to participate in public affairs.

Each year, the Zonta Club of Milwaukee awards a **\$1,000 local scholarship** to an applicant living in the greater Milwaukee area and forwards the winner's application to Zonta District 6 to be considered for the \$1,500 district award. The district winner's application is sent to Zonta International; 10 international recipients are selected from the worldwide district/region recipients to receive additional awards of \$4,000 each.

Who is Eligible?

Young women ages 16 to 19 (on April 1 of the application year) are eligible to apply, including Z and Golden Z club members.

(Classified members and employees of Zonta International and Zonta International Foundation, and their family members, are not eligible to apply. Previous International YWPA Award recipients are not eligible either.)

UN Report



Today, one in five young women will be married in childhood. Child marriage is a human rights violation on a vast scale and a major obstacle to sustainable development. Girls are disproportionately affected; child marriage is about five times more common among girls than boys, where approximately 4 percent of boys are married or in union before age 18. Around 650 million girls and women alive today were married in childhood, and unless progress is accelerated, that number will remain at least as high through 2030.



The global momentum and opportunities to make significant progress on ending child marriage have never been more favorable. The UNFPA-UNICEF Global Program to Accelerate Action to End Child Marriage offers a framework promoting the right of girls to delay marriage, addressing the conditions that keep the practice in place, and caring for girls already in union.

The program focuses on enabling girls at risk of child marriage to choose and direct their own futures, supporting households in demonstrating positive attitudes towards adolescent girls, and strengthening the systems that deliver services to adolescent girls. It also seeks to ensure laws and policies protect and promote adolescent girls' rights, and highlight the importance of using robust data to inform policies relating to adolescent girls.

Zonta International has committed US\$2,000,000 to UNICEF USA to support the UNICEF/UNFPA Global Program to Accelerate Action to End Child Marriage in 12 countries: Bangladesh, Burkina Faso, Ethiopia, Ghana, India, Mozambique, Nepal, Niger, Sierra Leone, Uganda, Yemen and Zambia.
