

Zonta Foundation



Your foundation board members are visiting the past year's grant recipients to see how our Zonta donations are being used, find out what is new, and inform programs of the opportunity to apply again.

I met with Executive Director Debbie Buchanan and got a tour of the **Milwaukee Homeless Veteran Initiative**, whose **WOVIN: Women Veterans Initiative** was one of our 2018 and 2019 grant recipients.

Milwaukee Homeless Veterans Initiative has been helping homeless and at-risk veterans since 2008. Their mission is to help homeless and at-risk veterans reach and maintain their highest levels of independence. Their programs fill the gaps that the government or other local agencies can't. These include an outreach program, home support, emergency food pantry, bikes for stripes and WOVIN.



WOVIN helps women veterans in particular – the fastest growing segment of the homeless population and of whom 25% have children. WOVIN strives to bridge the trust gap, inform women veterans of services they are eligible to receive, connect them with community services, and ensure their unique needs are being met. Our \$3,000 donation in 2018 helped over a dozen women vets with things like paying a security deposit, electric bills, car repairs and payments, hotel stays and post-surgery supplies and housing needs, as well as wellness event fees.

MHVI has many exciting things coming up. First, as of January 2020 they will be known as the Wisconsin Homeless Veterans Initiative, since they serve beyond the Milwaukee area (although 60 to 70% are within Milwaukee County). Second, they hope to find a bigger building in the general area of their existing building (63rd and National) so they can expand their services. They are outgrowing their space but want to stay near the other services provided. Third, they would like to expand their emergency food pantry to include healthy choices such as fresh fruits and vegetables and meats, and set it up more like a store. They also need space for a couple of crisis rooms where they can meet with clients. Fourth, they are looking to hire a Development Director and an Operations Manager (the latter to manage the warehouse where they store donations of furniture and other household items and clothing). (Debbie would be happy to hear of anyone you know who might be interested in these positions.)

I was very impressed with what they are doing.


"Around the World, Empowering Women and Girls"

UN Committee Report



At our October club meeting, the UN Committee took responsibility for the evening's Table Talk. Two topics were to be considered:

- What projects we are or have worked on that have met the United Nations Sustainable Goal #5, gender equality and empowerment of all women
- What projects we might undertake that support the United Nations Goal #5

There was general agreement across the tables that both the Zonta Says NO to Violence Against Women Walk and the Neu-Life Education Program on Human Trafficking are projects that address Goal # 5.

Across the tables, there were numerous suggestions for possible future projects as well as the thought that we could benefit from partnering with another organization already working on an established project.

- Further education on human trafficking to include other venues such as airports and hotels, as well as
 possible speakers for club programs to further educate ourselves
- Housing Justice A training program for young women on resources to help achieve safe and affordable housing
- Criminal Justice Reform Noting that there is a circle/connect with unstable housing and criminal activity of children who are impacted by the insecurity of their surrounding environment.
- An international and local activity, both addressing the issue of clean water.

Carol Mangold discussed the opportunity of attending the coming 64th session of the Commission on the Status of Women (CSW) to be held March 9-20, 2020, in New York City. Zonta activities will begin on Saturday, March 7, with a seminar on child marriage. Zonta's statement to the CSW will be submitted with Soroptimist International and is currently being routed for additional endorsements. The statement will then be posted on the Zonta International website per Megan Radavich, Assistant Executive Director, Programs and Advocacy, Zonta International.

Diane Lindsley, although not able to attend our meeting that night, has suggested partnerships with Milwaukee's Equal Rights Commission, the UNA of Greater Milwaukee, and WILPF, each of which would provide an intersection between international and local issues. She has also suggested a partnership in the local implementation of CEDAW, which is focused on ending all forms of discrimination against women. Since then, we completed three pilot programs and incorporated feedback from program participants and the community to refine the program.

None of this would be possible without Zonta. We're happy to announce that with their support, we have redesigned Neu-STEPP and are starting revisions to print the official toolkit.

Human Trafficking Legislative Update

State Sen. LaTonya Johnson's office reported that the Trucker Trafficking Education bill was signed Wednesday, November 20. Under AB22, commercial motor vehicle driver education courses offered by technical colleges or licensed private driver schools must provide instruction in the recognition and prevention of human trafficking. Per the *LaCrosse Tribune*, "truck and bus drivers are in a unique position to intercept instances of human trafficking, as many transactions and recruits take place at rest stops, with transport of enslaved individuals frequently done along the highway system."

Also signed into law that week was AB52, which allows homeless 17-year-olds to use a shelter facility or transitional living program despite being a minor. Homeless minors often end up being trafficked.

Zonta Says NO to Violence Against Women



According to a recent AP article, "Native American women experience some of the nation's highest rates of murder, sexual violence and domestic abuse. The National Institute of Justice estimates that 1.5 million Native American women have experienced violence in their lifetime, including many who are victims of sexual violence. On some reservations, federal studies have shown women are killed at a rate more than 10 times the national average."

Furthermore, "An Associated Press investigation last year found that nobody knows precisely how many Native American women have gone missing or have been killed nationwide because many cases go unreported, others aren't well documented, and no government database specifically tracks them."

A new initiative from the Justice Department "would invest \$1.5 million to hire specialized coordinators in 11 U.S. attorney's offices across the U.S. with significant Indian Country caseloads. The coordinators would be responsible for developing protocols for a better law enforcement response to missing persons cases."

The state of Wisconsin is also tackling the problem of violence against Native American Women. In September, bipartisan legislation was introduced to create a task force to address missing and murdered indigenous women and girls. According to an article in the *Milwaukee Journal Sentinel*, "Experts who have studied the issue say the legislation would be a good first step, but efforts to help Native American women shouldn't end there. The task force would examine the factors that contribute to higher rates of violence among Native American women and girls and what can be done to mitigate the violence. The group would present a report to the Legislature and tribal leaders with its recommendations in December 2020."

The bill is Assembly Bill 548. It was first read on October 14, 2019, and referred to the Committee on State Affairs. The text can be read at https://docs.legis.wisconsin.gov/2019/related/proposals/ab548.
