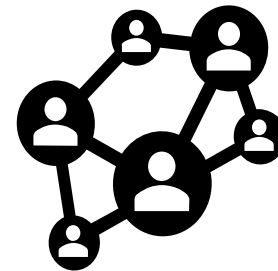
This month we will have the honor of installing new member Lynell Meeth at our Club meeting. Welcome Lynell!

## Why vaccine resistance? One Reflection...

Following is an excerpt from a NYT opinion piece on the tormenting decision to get the vaccine while being black in America:

*I don't trust doctors, nurses, physician assistants, hospitals, emergency rooms, waiting rooms, surgeries, prescriptions, X-rays, MRIs, medical bills, insurance companies or even the food from hospital cafeterias. My awareness of the pronounced racial disparities in our health care system strips me of any confidence I would have otherwise had in it. As critics of a recent Saturday Night Live skit suggesting that Black people are illogically set against getting vaccinated [pointed out](#), the vaccine hesitancy isn't due to some uniquely Black pathology. It's a direct response to centuries of anecdote, experience and data. ...*

*Existing in America while Black requires a ceaseless assemblage of negotiations and compromises. Even while recognizing the anti-Blackness embedded in society, participation is still necessary to survive.*

## News About the Equal Rights Amendment

The news is – there has been no progress. On Wednesday, March 17, 2021, the U.S. House of Representatives voted to remove the time limit with a vote of 222-204 on HJ Res 17. Attention now turns to the U.S. Senate and moving SJ Res 1 to the floor for a vote. See <https://www.equalrightsamendment.org/> You will notice Zonta International in the list of supporting organizations.

However, I thought you would enjoy information about Wisconsin and the Equal Rights Movement.

- In a 1912 referendum in Wisconsin, men in the state voted against women's suffrage by a wide margin -- proving that even in a state like Wisconsin, which at the time was a leader in the progressive movement, women's rights were not going to be given out without a fight.
- In July 1921, Wisconsin was the first state to pass an equal rights law for women.
- The move came after decades of women campaigning for suffrage and other rights.
- Wisconsin was also the first state to ratify the 19th Amendment to give women the vote.

### **WHAT FOLLOWS IS THE STATEMENT ZI SUBMITTED TO THE ECONOMIC AND SOCIAL COUNCIL OF THE UNITED NATIONS, DECEMBER 9, 2020: \***

“Zonta International is a non-governmental organization with General Consultative Status with the United Nations Economic and Social Council and participatory status with the Council of Europe. Zonta is also a member of coalitions like the Coalition to End Violence Against Women and Girls Globally, the ERA Coalition and others. Through these relationships and partnerships, Zonta is able to issue its own statements and collaborate with other like-minded organizations to make joint statements and advocate for policies to promote and protect the rights of women and girls.

Based on the above acknowledgement of our capability to issue statements, Zonta International, submitted the following statement to the United Nations Economic and Social Council’ Commission on the Status of Women:

Zonta International, a leading global organization of more than 28,000 professionals in 62 countries pledged to empower women through active service and advocacy, presents to the 75<sup>th</sup> Session of the United Nations Commission on the Status of Women the following statement for consideration of the Commission in its deliberations on women’s full and effective participation and decision-making in public life, as well as the elimination of violence, for achieving gender equality and the empowerment of all women and girls.

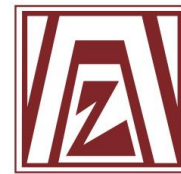
Today, the vision seems further away than ever. The world is facing unprecedented challenges, including a global pandemic, widespread gender inequality and climate change. While these challenges are felt by communities across the globe, they uniquely impact women and girls. The effects of COVID-19, in particular, have had devastating consequences for women and girls and threaten progress already made in the movement for gender equality.

### **MAKING THE CASE**

“The economic impacts of COVID-19, again while significant for everyone, are felt more harshly by women, who generally earn less, save less, hold less secure jobs and are more likely to work in the informal sector. Women’s health is also negatively impacted when resources and priorities, including sexual and reproductive health services are reallocated during times of crisis. Violence against women and girls has also increased exponentially during the COVID-19 pandemic. Widespread income loss and economic insecurity among families are also likely to increase the rate of child marriage. Climate change also disproportionately affects women and girls, from natural disasters, to food security, access to clean water, health and migration.

Zonta International calls on Member States and the United Nations to address the long-term impacts of COVID-19 and insure women and girls’ full and equal participation and decision-making in public life by:

- Addressing barriers to girl’s education...
- Ensuring girls’ access to quality education at all levels...
- Recognizing and elevating the voices of adolescent girls...
- Providing educational and leadership opportunities...



- Ensuring equal representation in decision-making bodies...
- Creating enabling environments for gender justice activists...
- Addressing cultural norms so that women, given the opportunity, can engage in paid work and be empowered economically...
- Guarantee adequate and equal remuneration for women's work and equal access to social services and protection policies...
- Creating working environments that facilitate women's participation in decision-making positions...
- Abolishing laws that restrict the types of jobs that women can do...

Covid-19, however, is not the only crisis impacting women and girls. Climate change also disproportionately affects women and girls, from natural disasters to food security, access to clean water, health and migration. Zonta International calls on member States and the United Nations to address the immediate and long term effects of climate change on women and girls by:

- Acknowledging and including women's voices about the harmful impacts of climate change, as well as listening to and learning from their attempts to mitigate and adapt to those impacts ...
- Developing policies and frameworks to address climate change that recognize its gender impacts and integrating gender equality and utilizing their unique perspectives...
- Recognizing the importance of women as decision-makers, educators, caregivers, community leaders and experts across sectors using it to develop successful, long-term strategies to address climate change...

Achieving gender equality and empowering women and girls will not be realized without elimination of violence against women and girls. Zonta International calls on Member States and the United Nations to address gender based violence by:

- Implementing the Beijing Platform for Action, the Convention on the Elimination of All Forms of Discrimination against Women and the Convention on the Rights of the Child...
- Ensuring that violence against women and girls is criminalized and appropriately punished...
- Developing, adequately funding and implementing national-level plans to end child marriage...
- Providing training and support to all those who interact and assist victims of violence...
- Dedicating specific resources to essential services for women and their families escaping violent situations...
- Including community leaders, men and boys, in efforts to eradicate violence against women and girls...
- Supporting the African Union's call for a treaty to end violence against women and girls..."

## Congratulations to our 2021 YWPA Recipient!

The scholarship committee selected **Briana Medina** of Dousman, Wisconsin as the 2021 Young Woman in Public Affairs award recipient. Briana is currently a Senior at the Kettle Moraine School for Arts and Performance. In high school Briana has held leadership roles in several organizations such as the KM Drama Club and the KM Tri-M Music Honors Club. In college Briana plans to study political science on a pre-law track with a goal to analyze policies, theory, and legislation in order to help people facing different injustices in the United States.

Briana currently interns with an organization called Done Waiting, which strives to hold politicians accountable and acts as a call to action for them to listen to their constituents' needs. As a Done Waiting Group Leader, she mentors a group in phone banking, text banking and more for progressive candidates and policies. She also participates in policy discussions. Briana participated in the 2020 Global Youth Leadership Conference, which is the official youth engagement group of the G7 industrialized nations. During this time, she wrote policies based on interactions with world leaders and the G7 and discussed current world issues with delegates from over 30 countries. In addition to the Global Youth Leadership Conference Briana has also participated in the SEE Summit, a national social justice conference and the 2020 World Affairs Seminar on Hunger. Briana is also a Girl Scout silver award recipient and currently working on her gold award. When Briana completes her post-secondary education, she sees herself impacting legislation related to reversing the struggles women face in America today.

  - Barbara Wyatt Sibley (1<sup>st</sup> year of 3-year term 2021-2024).

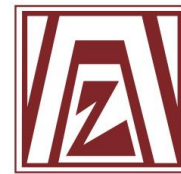
