



### CROSS-CULTURAL COMMUNICATION AND COMING ATTRACTIONS

The Racial Justice Committee held its regular monthly meeting on Thursday, Feb 3. We debriefed the January meeting with Heidi and discussed the format for the February meeting as well as one additional meeting, date yet TBD. In the February meeting, we will spend time exploring some other dimensions of culture, and dialogue about how conflict can show up because of cultural differences and misunderstandings. We'll try to schedule our final session with Heidi in this series for May or August. About a month before we meet, we will ask members to utilize the online Intercultural Conflict Style Inventory, an 18-item questionnaire and cross-culturally validated assessment tool, that we will be using and referring to in that meeting.

### **LOOKING FOR FEEDBACK**

We'd like to make feedback about our cross-cultural exploration a regular part of our process as well as a part of this monthly newsletter. At Club meetings after February, we'll try to spend 10 minutes or so discussing what we've learned about culture and communication, and how we're incorporating the learning into our Zonta activities and plans, particularly recruitment and retention.

We'd also like to include in the newsletter any reflections from members. Moving forward, please forward any feedback you'd like to share -- on either the Club meetings, or on how the learning has impacted the way you think or behave -- with either Donna Neal or Donna Kahl-Wilkerson, and we'll make sure it gets in the newsletter. To kick this off, we're sharing some of our Committee members' reflections on the January meeting:

I wanted to thank the club for supporting the concept of having Heidi Moore as our facilitator to work on our understanding of "What is Culture" and how can understanding help us meet across our differences. I particularly found the graphs interesting and helpful. The information presented allowed me to visualize some things about myself, such as the Monochromic and Polychromic dimensions of cultural differences, and enabled me to understand why I often feel out of sync - I am off the edge on the far side of the Polychromic line - always have been. I also feel, after Heidi Moore's presentation, that I understand more by what is meant by the term "Culture" - what it includes and how one might come to be/feel a certain way. I was originally thinking culture meant early years, parents, grandparents, places of origin. I see now that, I think, it is more how one comes to actually be the way one is by living. Although my early years and family had influence, it is my forty years in Ithaca, NY, that have given me my culture. Most of my time in Ithaca was spent working at a racially diverse public democratic decision-making middle school/high school. I worked with and grew close to staff, parent/caregivers, and, of course, students. LACS is a school community built on principles of equity, caring, and compassion, and is still thriving today. Being part of that community profoundly influenced (and still influences) how I see the world and my place in it. I am grateful for those years.

In school, we learned about other cultures in history, foreign language and/or music classes. Other cultures were either far away geographically or far back in time. We were never taught anything about contemporary cultures, much less any communication skills.

One must be nimble with communication methods, polychronic to monochronic and then perhaps back to polychronic, depending on an audience's understanding of one's messages.

Our Racial Justice meetings has been IMPACTFUL! Participatory activities provided an opportunity of self-introductions & self-assessments which increased our knowledge and awareness of members on an individual/personal basis.

Our January 26th RJ meeting focused on CULTURE, some key take away NUGGETS were:

- CULTURE, defined as "WAY OF THINKING & LIVING".
- Two dimensions of cultural differences introduced monochromic (time exact, task oriented) & Polychromic (inexact, free flowing, relationship building focus). We graphically identified our culture on the graph between monochronic – polychromic. This activity was masterful in alerting individuals to their cultural response in relation to the club's cultural response.
- Cultures affects our behavior, thinking, and patience.
- Understanding of cultural differences is gained by experiencing them.
- Culture is learned not inherited.

The Racial Justice presentations has been educational, <u>insightful</u> and meaningful. Looking forward to the next one!

### **Equal Rights Amendment Update**

In an <u>opinion</u> issued on Wednesday, Jan. 26, the Department of Justice's Office of Legal Counsel (OLC) helped clear the way for the Equal Rights Amendment, according to leading ERA advocates. In January of 2020, under Trump, the OLC issued an opinion arguing that Congress had no power to remove a seven-year timeline for ratification in the preamble of the ERA and that therefore three recent state ratifications were invalid. The OLC opinion issued by the Biden administration strongly affirms the power of Congress to remove the deadline. The opinion follows the overwhelming consensus among constitutional law scholars.

According to a <u>recent amicus brief</u> authored by former Stanford Law School Dean Kathleen Sullivan and signed by Laurence Tribe, Dorothy Roberts, Kimberlé Crenshaw, Catharine MacKinnon and 11 other top constitutional scholars:

"The language of Article V is mandatory: an amendment to the Constitution 'shall be valid to all intents and purposes, as part of this Constitution, when ratified by the legislatures of three fourths of the several states.' Nor does the text of Article V envision a role for an executive branch officer to assert his discretion regarding the validity of the amendment. The text requires no additional action by Congress or by anyone else after ratification by the final State."

In a <u>press conference</u>, Reps. Carolyn Maloney (D-N.Y.) and Jackie Speier (D-Calif.) responded to the newly issued OLC memo by saying that the ERA has already been ratified and should be recognized as the 28th Amendment—and that the archivist should do his ministerial duty to certify and publish the ERA. Action by Congress could clarify this but is not necessary for publication of ERA.

Also on Jan. 27, President Joseph Biden issued a statement reiterating his strong support for the ERA and

urged Congress to pass the resolution. "No one should be discriminated against based on their sex—and we, as a nation, must stand up for full women's equality."

Removing the deadline for the ratification of the equal rights amendment. That notwithstanding any time limit contained in House Joint Resolution 208, 92d Congress, as agreed to in the Senate on March 22, 1972, the article of amendment proposed to the States in that joint resolution shall be valid to all intents and purposes as part of the United States Constitution whenever ratified by the legislatures of three-fourths of the several States."
