On April 10, Area 2 workshop was held in Madison. Our club was represented with five members attending. Governor Buffie Kelley presented a session on Service and Advocacy with an activity which asked participants to identify service projects their club was involved in which meet or did not meet the scorecard criteria outlined by Zonta International. Our club has worked very hard and continues to do so to ensure the service projects we are involved in align with Zonta International's goals. The guest speaker, Mary Bub, discussed the plight of rural women in Wisconsin with emphasis on health insurance and domestic violence. There my be opportunities in the future for our Club to partner with her organization with a program called "Bridge of Undertanding" that brings together women from rural areas and women from urban areas to discuss key issues related to each group and gain new perspectives relative to each other.

There was a update from the two Thailand students we have assisted in supporting at UW Stevens Point. They shared lessons learned and future plans when they graduate and return home. It was very up liifting to hear their stories. They commented that they like the snow!! It's pretty at first but like us, they get tired of it quickly. Lt. Governor Yvonne Chalfant presented on the topic of "Insights and projections for the next Biennium". She posed four very important questions that we as a Club should be asking ourselves: 1) What are you doing? (personal and club perspectives); 2) What in the world are you doing?(global vision); 3) Who do you think you are? (community advocates-specialists on women issues); 4 What will you think of next? (face of our club in 2-5 years). We will explore these in more depth at a future meeting.

We rounded out our day by attending the 50th anniversary of the Zonta Club of Janesville. The event was held at the Rotary Gardens, a beautiful facility and a great time was had by all.

Our first stop in Springfield is **The Abraham Lincoln Presidential Library and Museum**(9:00 -11:00am) where we visit the museum. Life-size dioramas depict Lincoln's boyhood home, areas of the White House, the presidential box at Ford's Theater, and the settings of key events in Lincoln's life, as well as pictures, artifacts and other memorabilia. Leaving Springfield we travel to St. Louis making a lunch stop, (on own) along the way. Arriving in St. Louis we will be visiting the **St. Louis Cathedral** (2:00pm) and the world famous **Missouri Botanical Gardens** (3:00-5:00pm). Later we check into our hotel, **Drury Plaza Hotel at the Arch** in St. Louis, MO (5:30pm),

Breakfast (Incl.)@ Inn,Leave hotel (8:30 am).

(Complimentary cocktail reception,(5-7pm).Dinner (incl)tonight at The Old Spaghetti Factory located inthe historic warehouse district, Laclede's landing.

### June 21 (Mon)3)

Here is where Elvis first recorded. Your guide will tell you the inside stories of BB King, Howlin' Wolf, and Ike and Tina Turner before Elvis...and Johnny Cash, Carl Perkins, Jerry Lee Lewis, & Roy Orbison who were all drawn to the new Sun Sound. Lunch (on own). Visit -Graceland Mansion, (1:30 - 3:30pm) for a tour of Elvis Presley's home. Experience life as Elvis did at historic Graceland. The Mansion tour includes the living room, music room, Elvis' parent's room, dinning room, kitchen TV room, pool room and jungle room. Walk the estate grounds including the meditation garden and grave sights of Elvis and his family. Check into the Comfort Inn & Suites. Freshen up before this evening's **dining experience**, (Incl.).
