Presidents Message.....

Dear Sister Zontians:

The Spring Workshop was held in Stevens Point, WI this past weekend with the theme: "The Dynamic Duo Service and Advocacy. We were warmly welcomed by Gail Zalewski of the Stevens Point Club along with our Area 2 Director Sylvia Armstrong. An International Foundation update was provided by Sally Bean, District 6 International Foundation Ambassador who provided us with insights on the Zonta International fundraising goals as well as an overview of ZI and ZISVAW projects. She highlighted information on a new project this bienneum -Acid Burns Violence in Cambodia, Nepal and Uganda sharing power points and detailed descriptions of the violence as evidenced first hand by some women.. Hearing their stories was both heart wrenching and heartwarming to know that we can and do make a difference in the lives of women worldwide.

The Club Presidents provided information on service and advocacy projects their respective Clubs were involved in and the successes of those projects Our luncheon speaker was Mickey Beil, Legislative Lobbyist for Wisconsin. She provided valuable resources on the most effective ways to communicate with your legislators and the 10 commandments of lobbying.

We then were engaged in a lively workshop presented by Tammy Hagen and Joann Gruber-Hagen from the Zonta Club of Madison on the distinctions between service ad advocacy or to determine if there really is one. Table groups were assigned to pick an issue and using a grid select advocacy actions that could be taken an the selected issue s well as service actions. The groups reported out and several good ideas surfaced that cold be implemented in our respective Clubs.

The highlight of the workshop for me was the presentation by District 6 Governor Yvonne Chalfant on 13 ways to inspire change. She showed a DVD which accompanied book entitled **Change is Good...You Go First** by Mac Anderson and Tom Feltenstein. The 13 ways are:

- 1. Change what needs changing, not what's easy
- 2. Re-recruit your best people
- 3. Forget for success
- 4. It all starts with belief
- 5. Focus on your strengths
- 6. Remove barriers
- 7. Simplify your message


North American Inter-District Meeting

delegate at the United Nations' World Conference on Women that was held in China in 1995. "I've seen much of it and still have friends there with whom I correspond by e-mail. I get a call from there once a week." Although she doesn't speak Mandarin, she understands it.

"I travel somewhere every year, sometimes twice a year," Rockjordan says. She has been to Korea and on a safari in Botswana. In Thailand, she rode an elephant into the hills. In Tunisia, she rode camels. She hopes to go on another safari, "perhaps in Tanzania and Kenya."

Rockjordan has often been a trailblazer. During World War II, she got a job out of high school working as a timekeeper for the Brooklyn Navy Yard. She was one of only two women who were production welders. She also worked on the conning tower of the USS Missouri as a welder. Later, she attended Long Island University, where she was "the only woman and only minority in the business school," Rockjordan notes. She got a master's degree in business administration from New York University and broke the color barrier again when she was hired to work in executive positions for exclusive department stores and dress shops.

During the Korean War, Rockjordan lived in Japan for three years and worked as a civilian for the Air Force in special services. She set up tours of Japan and Korea for American military and U.N. personnel. She received a recognition award from Sweden's King Gustaf for her work with Swedish personnel.

Later in her life, Rockjordan became an academic. She got her master's degree and was for decades a tenured professor in social work at UWM. She's still a professor emeritus. She also taught at both UWM's and Marquette's extensions.

Rockjordan will admit only to being older than 85. Her motto is, "Life is to be lived. I don't feel you should sit and wait for the grim

Living alone in her condominium in Parkway Village on Milwaukee's far Northwest Side, she takes care of everything in her life - cooking, cleaning, shopping and then some. She loves to drive and still takes road trips alone. Last year, she drove alone to Wilton, Iowa, to meet a friend from Korea who was visiting

Rockjordan is a joiner. Until a few months ago, she served on the board and was the treasurer of the Parkway Village Association. She has also served on the board of the Wisconsin Condominium Association. Presently, she notes, "I'm a member of Zonta, an international association of business and professional women, and am active in the group." She's also a past president of the Zonta Club of Milwaukee.

Tall for a woman of her generation, Rockjordan is 5-foot-7 and stays in shape. She exercises at a health club two to three times a week. She's a nature-lover and walks five miles on the Oak Leaf Trail in nice weather, "I like things that are related to nature; when I travel, I will go to national parks."

Rockjordan has an active social life and friends of varied ages. She loves music and frequently goes to the ballet, opera and symphony.


