# Driving Directions for Holiday Gathering at the home of Kim Brinsko

<u>Directions coming from the Western suburbs and Downtown area</u>

- 1. Merge onto I-94 E
- 2. Take exit 310B to merge onto I-43 N
- 3. Take exit 283 Port Washington Rd.
- 4. Turn right onto N Port Washington Rd going South. Proceed for .3 miles Approx.
- 5. Turn Left onto Manor Circle. It is adjacent to Bayside Commons Condo's Destination will be on the right in approx. 3 miles (Pass the stop sign). The house is on the south side of the street with the large evergreen tree and multicolored lights on the shrubs.

Please note that I do not have you exiting on Brown Deer Rd. If you are unfamiliar with this exit, it can be confusing and difficult especially at night.

<u>Directions coming for the Northwest of Milwaukee and</u> Northwest Suburbs

- 1. Take Brown Deer Road (or Main Street in the Falls) east to Port Washington Road.
- 2. As you approach Port Washington Road (W) go in the far left lane for a left turn onto Port Washington Road. And stay in the left lane as it will go down to one lane.
- 3. Continue for .6 mile and Manor Circle will be on the right side adjacent to Bayside Commons Condo's. Turn right and proceed .3 miles (Pass the stop sign). The house is on the south side of the street with the large evergreen and multicolored lights on the shrubs.

#### **Directions coming from Ozaukee County**

- 1. Take Port Washington road going south and proceed to Manor Circle. (approx. 1.2 miles from Fairy Chasm)
- 2. Turn Left onto Manor Circle. It is adjacent to Bayside Commons Condo.' Destination will be on the right in approx. .3 miles (Pass the stop sign). The house is on the south side of the street with the large evergreen tree and multicolored lights on the shrubs.

Please park on the right side of the street. South


