## Violence Against Women – A Response from India

Many Zontians around the world joined the outrage of many millions of people when they learned of the rape and death of a 23 year-old woman in New Delhi, India. A new report proposing ways to tackle violence against women in India was praised by the United Nations High Commissioner for Human Rights, Navi Pillay who urged the Indian government to follow through with the Verma Committee's recommendations.

The report was produced by the Verma Committee, named after former Chief Justice Jagdish Sharan Verma. The report recommends a number of sweeping changes. They include punishment for marital rape, domestic rape and rape in same-sex relationships. They require police officers to record every case of rape. Those police officers who fail to register every case of rape reported to them face serious consequences. The report recommends that police and armed forces must be held accountable for sexual violence. It also recommends punishment for stalking and voyeurism with prison terms.

Thankfully the report also calls for changes in the way rape victims are treated. It changes the humiliating protocol for medical exams, cracks down on village councils which hand down their conclusions on such cases. Many times these village councils issue pronouncements against women. The report calls for improved sexuality education in both schools and communities. It asks for new legal requirements to ensure that people charged with criminal offenses may not hold political office.

"The Committee's recommendations are grounded in a framework of rights, equality and nondiscrimination and represent a paradigm shift towards recognition of women as holders of rights, not just objects of protection," said Ms. Pillay. She continued, "The report should serve as a beacon for many other countries struggling to respect the rights of women more comprehensively by addressing sexual violence through legislation, policies and programmes."

Now we can only hope that the Verma Committee's recommendations are put into effect.



## UN Secretary General Ban Ki-moon's Five Year Agenda

The UN Secretary General Ban Ki-moon recently discussed his five year agenda which concentrates efforts on working with and for women and young people. It has four parts. First is to deepen the UN campaign to end violence against women. He proposes that this can be done by increasing support for countries so that they may adopt legislation that criminalizes violence against women. Such legislation should also provide for reparations and solutions to victims. The legislation should also provide women with access to justice while it provides for pursuing and prosecuting perpetrators of violence against women.

A second part would promote women's political participation worldwide. This could be done by encouraging countries to adopt policies and measures that guarantee women's equal access to political leadership. Elections should be managed in a way that facilitates women's engagement in the political process and that will develop the capacity for women to become effective leaders. He emphasized his seven-point action plan on women's participation in peace building which could act as a focus.

The third step is to develop an action agenda for ensuring the full participation of women in social and economic recovery. A partnership with government, the private sector and civil society could help bring about changes in inheritance laws, wages, childcare and taxes.

The last step is to address the needs of young people. At present the world has the largest generation of young people that it has ever known. The focus on young people has to be deepened and must concentrate on employment, political inclusion, protection of rights and education, including reproductive health. The UN system will develop and put into place an action plan. In doing so it would create a youth volunteer program under the "umbrella" of the UN Volunteers and appoint a new Special Adviser for Youth.

The Secretary General has always pressed for more action in the realm of violence against women. Zonta's public relations plan, Zonta says NO, supports all that he has proposed. All of our districts and clubs should be emphasizing this plan.

# International pact would curb worldwide gender discrimination.

One of the distinguishing features of American foreign policy is its claim of moral authority in the field of human rights. Our politicians regularly cite America as a beacon of freedom and as a champion of the cause of human dignity across the globe. Yet, in at least one important instance, America lags behind.

The United States remains the <u>only industrialized</u> <u>democracy</u> not to have ratified the Convention on the Elimination of All Forms of Discrimination Against Women, a watershed international agreement that protects women and girls from unfair treatment and abuse. In fact, only six other states in the United Nations -- <u>Iran, Sudan, South Sudan, Somalia and two Pacific Islands</u> -- have failed to approve the treaty.

Last week, a coalition of more than 100 organizations cosigned a letter urging the Senate to ratify the treaty in the 113th Congress. President Obama endorses ratification, and has identified the Convention as a multilateral treaty priority. The Senate must seize this moment, and ratify the women's rights convention. It must not play the same shameful partisan politics that it did with the disability rights convention, which it rejected just one month ago. The international bill of rights for women, as it's often called, was drafted in 1979 to help curb worldwide gender discrimination. A decade later, the economist Amartya Sen described the problem best when he noted in an article that more than 100 million women were missing from the world. Sen concluded that men outnumbered women because of disparate access to education, health care and

economic opportunity. There was also mounting evidence at the time that gender equality was correlated positively with economic development and democratic reform -- a principle now espoused by economists worldwide. The treaty recognizes that women's rights are human rights and, like genocide and racial discrimination before it, merit their own international commitment.

Countries that ratify the treaty agree to take "all appropriate measures" to ensure that women receive equal and fair treatment. They commit to providing periodic reports documenting their efforts to a 23-member committee, which makes recommendations regarding best practices. The committee has no enforcement authority and its recommendations are non-binding. Its power is persuasive and rests on an unwavering belief that self-evaluation and international dialogue leads to positive change for women and girls. Public reports make states accountable to the world, and empower NGO's and citizens, both at home and abroad, to take action.

Success stories from those countries that have already ratified the treaty abound. In 2005, Kenya ended inheritance discrimination against widows and daughters based on guidance from the committee. In the same year, Kuwait gave women the right to vote following the committee's recommendation. By 2009, each of Mexico's 32 states had adopted language from the Convention in legislation to end violence against women. Bangladesh has committed to eliminating gender disparities in secondary education because of the public dialogue emanating from its periodic reports.

Ratification will allow the U.S. to participate in this international dialogue, and stand up for women's rights. U.S. Ambassador for Global Women's Issues, Melanne Verveer, testified last year that U.S. ratification "would lend much needed validation" to women seeking greater political and economic expression in the Middle East in the wake of the Arab uprisings. As it stands, major human rights violators cite America's failure to ratify the treaty as evidence that women's rights aren't universal.

Approval of the treaty will also aid our own continued progress. According to the World Economic Forum's 2012 Global Gender Gap Report, the U.S. ranks 22nd in the world in gender equity. Domestic violence persists, pay discrimination lingers and the U.S. ranks last among all industrialized nations in maternal health. San Francisco has already profited from the Convention's time-tested processes. The city recently reduced gender discrimination in hiring and retention after passing an ordinance implementing the treaty's self-evaluation process on a local level.

Critics have charged that the agreement undermines national sovereignty. Yet, the Convention relies entirely on voluntary cooperation and advisory recommendations. Should the U.S. ratify the treaty, our elected officials would be responsible for determining what measures are appropriate to advance its goals. The women's rights treaty affirms fundamental American values of fairness and opportunity for all.

In his Nobel Peace Prize acceptance speech, President Obama declared that "America cannot insist that others follow the rules of the road if we refuse to follow them ourselves."

The time for rhetoric is over. If America seeks to promote the cause of women's rights, the Senate must take action and ratify the international bill of rights for women.
