#### Zonta Foundation— Action Required

The 2011 application for grant money for 2012 is now available. Any member who knows of an organization aligned with Zonta's goals that (s)he believes is possibly worthy of a grant from the Milwaukee Zonta Foundation, Inc., may forward an application directly to that organization (application attached), or request that the Foundation Board forward an application to that organization – forward request electronically to donnaineal@gmail.com. We want to surface as many worthy applications as possible in these economically troubled times. In the past, grants have typically ranged from \$1000 to \$3000 annually over 1 to 3 years, though past actions are not necessarily predictive of future decisions. This year, the Foundation Board will give extra weight to applications that address issues facing girls or young women in Milwaukee, in line with the strategic direction of the club. The application due date is December 15.

#### Joint Board Task Force Update

Reminder: In our April meeting the Club determined that girls/young women should be our long term-strategic focus, with education a secondary and clearly related focus area. (See photo)

Your Joint Board Task Force has been working tirelessly this summer and early fall to educate ourselves regarding current and emerging issues facing girls and young women in Milwaukee and programs addressing those issues and needs. We have been interviewing a number of community service agencies as well as exploring more academic/statistical research to gain perspective and begin to prepare a short list of potential partners. We plan to bring a more detailed update to the club meeting in November. Connections so far have been made with CORE/El Centro, Heartland Place, Pearls for Teen Girls, Girl Scouts of SE Wisconsin, Neu-Life after school and summer programs, the Center for Entrepreneurship, Sojourner Family Peace Center, Alverno Center for Research on Women and Girls, and others. We're in the process of compiling our interviews and research. We expect to have multiple options for the Club to consider for long-term engagement. There is no shortage of need and no shortage of opportunities for Zonta Club of Milwaukee impact.

## Legislative Awareness and Advocacy

On September 23rd, Cheryl Lukas-DeBerry and I were invited by the International Women's League for Peace and Freedom (WILPF) to attend a consultation with Susan Braden of the US State Dept. about UN Security Council Resolution 1325 "Women, Peace and Security". Milwaukee was the first of five consultations with women's groups also scheduled for Detroit, San Diego, Portland and Boston. They will provide critical feedback towards the development of a U.S. National Action Plan for compliance with Security Council Resolution 1325 governing women's involvement in post-conflict negotiations and peace-building, with the goal of preventing future armed conflicts. It is WILPF's position that "women living in the United States should and must be heard and integrated into our national security policies and programs."

I used that opportunity to speak for the ratification of the CEDAW Treaty. The feedback we received from WILPF was that Susan Braden grasped for the first time how the domestic issues that American women face are intricately connected with the same issues women face globally. A WILPF member who recorded the consultation stated "Milwaukee was pretty amazing, with lots of important topics raised from versions of masculinities in the U.S. to the need to address access to justice, health, and living wage jobs for women in U.S as well as sex trafficking to low maternal mortality and high poverty rates of women."
